Coupons

- Only one coupon per customer at any one transaction.
- Please present the coupon before you make your transaction.
- Other terms & conditions of the advertiser, may apply.
- Always check with the advertisers before use.

Advertisers Terms & Conditions

- 1) A copy of your logo should be sent before the copy deadline date (*usually 12 th of the Month preceding delivery*). If you have requested that your logo to be designed by us, it is your responsibility to ensure that you give us the correct information about your business, i.e. contact details, prices, descriptions etc. and you must proof check your coupon by the deadline date.
- 2) Business logo's submitted to us should be in at least one of the following formats: PDF, TIF, PSP, JPG or PHOTOSHOP they may be submitted by E-mail to info@discounts-directory.com or sent on a disk to discounts directory at address on overleaf before the deadline date.
- 3) We take no responsibility for the content of your coupon. It is your responsibility to ensure that your coupon is legal and copyright free.
- 4) We reserve the right to refuse advertisements which may be defamatory or offensive or which promote products that may be considered indecent.
- 5) We can make no guarantees that your ad will be successful; therefore we are unable to offer you a refund if you receive no response. The cost of your ad covers the cost of printing, distribution, website and the promotion of the directory.
- 6) For the best chance of success, we recommend that you advertise for three or more issues. As the readers become familiar with your coupon, they are more likely to remember you should they need your product or service at a later date.
- 7) When you book your coupon space, you are agreeing to pay the current price upfront.
- 8) For booking advertisements in three, six or twelve issues, you may choose to pay in full or per month of your coupon. In cases of overdue accounts, we will exercise our statutory rights under the Late Payment of Commercial Debts (Interest) Act 1998. In this respect, interest at the rate of 3 per cent above base rate per 14 day period will be added, compounded in each 14 day period on any outstanding balance from the date of the invoice until the date of receipt of payment in full. Also, please be advised that, in accordance with European Directive 2000/35/EC, a debt recovery fee of £40 will be charged, an admin fee may also charged at £24 should we have to send out reminder letters.
- 9) For booking advertisements in three, six or twelve issues, you may choose to pay per month or in full, you are tying into contract with discount-directory.com and if you wish to

cancel your coupon there will be a charge of 10% for the following coupons still to be printed.

10) If you have booked an ad for three issues or more and cease trading during this period, it is your responsibility to contact us to remove your coupon. If you have paid in advance, you will receive a refund for the outstanding bookings - £24 admin fee.

11) If you wish to upgrade your coupon to the front page during your booking period, you will be sent an invoice to cover the increased cost, however it is your responsibility to check with us in advance to avoid disappointment as discount-directory.com spaces are very limited and timescales vary.
